

# Consent Declaration for Meetings

## 1. Introduction

- 1.1. By accepting this consent declaration, consent is granted for the Organization's processing of personal data as described below and in the Organization's data protection policy, which is made available alongside this consent declaration.
- 1.2. If this consent declaration is accepted in physical, printed form, the Organization's relevant Privacy Policy can be found either on the Organization's website/intranet or as a physical, printed attachment to the consent declaration. If this consent declaration is accepted via email or digital signing, the relevant Privacy Policy is either attached or otherwise made available prior to or concurrently with this consent declaration.

- 2.1. The consent covers the following types of personal data: name, phone number, and email address.

## 3. Purpose of Processing Personal Data

- 3.1. The Organisation processes the personal data covered by this consent declaration for the following purpose:
  - a) To uniquely identify the registered individuals.

## 4. Storage

- 4.1. The Organization will process your personal data solely in accordance with your consent for as long as there is a valid purpose for doing so:
  - a) Contact in connection with meetings, etc.

- 6.2. Right of Access (Insight)
- a) You have the right to access the information that the Organization processes about you.
- 6.3. Right to Rectification (Correction)
- a) You have the right to have incorrect information about yourself corrected.
- 6.4. Right to Erasure
- a) In certain circumstances, you have the right to have your information deleted before it would otherwise be erased under our general retention practices.
- 6.5. Right to Restrict Processing
- a) In specific cases, you have the right to request that the processing of your personal data be restricted. If you are entitled to this, the Organization may only process your data in the future (except for storage) with your consent, for the establishment, exercise, or defense of legal claims, to protect important societal interests, or to protect an individual.
- 6.6. Right to Object
- a) In certain cases, you have the right to object to our otherwise lawful processing of your personal data. You may also object to the processing of your data for direct marketing purposes.
- 6.7. Right to Data Portability
- a) In certain circumstances, you have the right to receive your personal data in a structured, commonly used, and machine-readable format, as well as to have the data transferred from one data controller to another without hindrance.

## **7. Withdrawal of Consent**

- 7.1. The consent provided in this declaration is given voluntarily and may be withdrawn at any time by contacting us using the details provided below.
- 7.2. Upon withdrawal of consent, the Organization will delete the personal data processed under the consent. If the consent includes the processing of personal data that, in accordance with the consent, has been printed or made available in physical media, the Organization will delete the physical media within its possession upon the withdrawal of consent. However, the Organization cannot guarantee the deletion of any copies of physical media that are not in its possession at the time the consent is withdrawn.

## **8. Complaint to the Swedish Authority for Privacy Protection**
